CyPRSS Software

CyPRSS provides a repeatable approach for secure boot, extension of trust, and continuous remote attestation for multiple distributed 'agnostic' Roots of Trust (RoT), extending the traditional RoT model to incorporate multiple RoTs from multiple system components or sources forming a lattice-based access network above typical OS and Network trust.

Obligations of Licensee

Initial Software Maintenance Services (SMS)

SMS will be provided to a Licensee by Northrop Grumman without additional charge for the initial twelve (12) month period following receipt of license Fees ("Initial Support Term"). SMS is provided to Licensee only if an initial purchase of the Licensed Software has been made.

Beyond the initial support term, no SMS, implementation support, or other support services or technical assistance will be provided to Licensee. If Licensee desires to continue SMS, then the parties must purchase SMS licenses to provide SMS, as priced below.
