


Upcoming Construction – Bethpage Community Park Test Pitting Work

This fact sheet provides an update on our ongoing New York State Department of Environmental Conservation (NYSDEC)-approved projects at the Bethpage Community Park in Bethpage, New York.

In 2024, Northrop Grumman conducted geophysical surveys of the Bethpage Community Park (Park). In response to the survey results, in June 2025, Northrop Grumman excavated 18 test pits in a 3,600 square foot area in the ballfield and located various metal objects. Northrop Grumman will continue to excavate 30 additional test pits at the Park (identified as red boxes in the image below) to investigate the inferred buried metallic objects seen in the survey. The excavator will dig between three to 16 feet below ground.

During the construction, test pits in publicly accessible areas will be safely secured with fencing. If grossly contaminated soils are observed in a test pit, they will be staged next to the test pit, sampled for laboratory analysis, covered, and secured within the work area while awaiting analysis. Impacted soil will be moved to a fenced central staging area, containerized, and stored while arrangements are made for off-site disposal. Work began on December 1, 2025, and will be completed this month.



Work Equipment

Site equipment will include an excavator, transport truck for the excavator, small dump trucks, skid steer with bucket attachment, and personal vehicles.

Work Schedule and Locations

Work hours are Monday through Friday from 8 a.m. to 5 p.m. (except Town and Federal holidays) and work is weather dependent.
